

## **SAG-AFTRA SINGERS ANIMATION DEVELOPMENTAL WORKSHOP THEATRICAL WAIVER**

January 10, 2014

The SAG-AFTRA Singer Animation Developmental Workshop Waiver shall be available to the composer or producer of record upon request. Once requested and approved, the waiver shall apply to all sessions recorded during pre-production for the same approved title/project.

The waiver shall be available for use during the pre-production period only, where musical material, story line, and character concepts are being developed and workshopped simultaneously for use in Animation productions under the SAG-AFTRA Theatrical Agreement.

Session length under the Animation Developmental Workshop Waiver shall be 6 hours, and unlimited sweetening and/or multi-tracking shall be included. The session fee shall cover all Solo/Duo or Group performances. The overtime rate shall be computed at: 7<sup>th</sup> and 8<sup>th</sup> hours @ the pro-rated hourly, 9<sup>th</sup> and 10<sup>th</sup> hours @ the time and one-half (1.5x) rate, and 11<sup>th</sup> hours plus @ the double time (2x) rate.

There shall be a vocal contractor required on all sessions of three or more group singers, and the vocal contractor fee shall be 50% of the session fee. The vocal contractor shall be required to complete and file a SAG Singers Member Report for every group session done under the "umbrella" of the production title/waiver. The Report must include accurate indications of all work performed, i.e. Size of group, whether or not Sweetening or Multi-tracking was performed, indication of a Solo Step Out, Solo/Duo, etc... These filed Member Reports with SAG serves as a reference in the event that the workshop material is included in any final product, and will dictate the proper additional payment of all applicable scale. No vocal contractor shall be required for Solo/Duo sessions, and the Solo/Duo singers will be responsible for filing their own SAG-AFTRA Singers Member Reports.

Hourly breaks as required under the SAG-AFTRA Theatrical contracts shall apply, and the standard Singer session cancellation penalty shall apply. A meal period of 30 minutes shall be given for every 6-hours on a session.

The applicable fee for the Animation Developmental Workshop Waiver session shall be \$465 (or 50% of the current solo/duo rate in the SAG-AFTRA Theatrical Contract) and shall be increased to reflect any percentage increases to the SAG-AFTRA Theatrical Contract rates during the effective period. The current pension & health contributions under the applicable SAG-AFTRA Theatrical Contract shall be required for the session work.

Any work created under the SAG-AFTRA Singers Animation Workshop Waiver may be converted for inclusion in the final marketed product, score, etc. but if used, the singers are entitled to an additional 100% of the total applicable daily rate, and reflecting any step-out, multi-tracking, or sweetening fees for such work as indicated on the original contract and SAG Singer Member Report form.

Except as otherwise stated here, all other terms and conditions of the SAG Theatrical Contract would apply.
